The Institute is situated at SICOP Road, Bijbehara. It was established in November, 2000. The Institute is recognized up to 10th Standard and is running classes from Nursery to 10th Standard. Last extension in recognition to the Institute has been granted vide Government Order No. 1085- Edu of 2013 dated 31-12-2013.

Total classes run by the Institute are 13. Total student strength is 300. Class wise student strength of the Institute are: Nursery: 25, LKG: 18, UKG: 15, 1st: 23, 2nd:26, 3rd:28, 4th: 27, 5th:21, 6th:20, 7th:27, 8th:25, 9th:26 and 10th:19.


