Complaints are flooding this office against DPS, Delina, Baramulla and recently 3 more complaints are sent through e-mail by Dr. Zahoor Ahmad Makhdoomi on 14.11.2020 at 12:10 pm, Mr. Gazi Fayaz, President, DPS Parents Association on 04.12.2020 at 12:52 pm and Mr. K Bilai Fazili on 04.12.2020 at 02:40 pm. One common thread running in these complaints is withholding of results of the students in the face of alleged non-clearance of fee.

An educational institution is primarily established to impart education to the students admitted therein. True it is for performing duties and running the affairs of the private educational institution the guardians/parents have to share the responsibility thereof.

Time and again school managements are being reminded that an educational institution is not being set up as a business unit for making commercial benefits, but is being established to impart education to the students. This duty is one of the most cherished duties and it is for this reason that after parents, teachers and those who facilitate imparting of education are highly and widely respected in the society.

The issues about tuition fee, annual fee, transport fee etc. would be settled in accordance with the settled norms. The school, however, cannot hold students' future as hostage for realising money from their parents/ guardians. Such instances can never be found in the pages of human history. Such an action is against the human ethics and normal course of conduct of human affairs. It is an illegal act which cannot be countenanced in law.

The school management of DPS, Delina, Baramulla is directed to forthwith declare the results of all the students irrespective of the fact whether fee has been paid or not. The management is further directed to take all steps thereby enabling all the students to take online classes and should be continued on the WhatsApp groups of classes. Compliance report be sent to this office within 2 days time, failing which action in accordance with law will be initiated against the management of the school.

The issue about fee dues will be resolved and parents/guardians shall pay the fee which they are required to pay according to the norms fixed by the competent authority.

Copy of the complaint(s) alongwith order be mailed to the chairman and principal DPS, Delina, Baramulla for their compliance. They are at liberty to file response also to the complaint which will be taken up at Committee for Fixation and Regulation of Fee of Private Schools J&K (FFRC) at Hyderpora, Srinagar on 23.12.2020 at 11:00 a.m.
