Dated: 27 -03-2021

Sub: Fixation and Regulation of fee of Christ School Poonch.

Christ School Poonch submitted its file registered by this Committee under No. FFRC/FF/2018-21/Pnch/207 for fixation and regulation of fee structure of the School.

On examination of the record it was found that the annual Fee being charged by the School at present has not been fixed and regulated by the Committee so far and is being regulated for the First time. It also transpired that the school in utter disregard of the terms and conditions laid down in the order No. 01 FFC of 2019 dated 28-01-2019 has abruptly jumped from Rs. 3395 in 2018 to Rs.6000 in 2019. It may not be out of place to mention that the order No.01 FFC of 2019 has been revoked vide No. 44 FFRC of 2021 dated 18-02-2021 and is non-existent as on date.

On due consideration of the pleas raised by the School management and after considering the record, all relevant factors which govern the subject, and the trend in expenditure incurred by the school, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
