The school has been charging Annual fee without approval of the Committee and is being regulated for the first time. The management is charging Rs.1300 as school improvement fund (Annual Depreciation) and Rs.800-900/- as Student welfare fund. The depreciation amount as per the expenditure statement may have been more or less Rs.800/- and there is no mention of any student welfare related expenditure in the expenditure statement and therefore has no relevance to be a component of annual fee hence the same is deleted from annual fee component annual fee. Taking 2018-19 as base and annual depreciation amount as Rs.800



instead of Rs. 1250, the annual fee of the School is fixed and regulated as per the set norms as under;-
