Nav Jagriti Niketan Hr. Sec. School Kharote MORE Kathua submitted its file registered under No. FFRC/FF/219-21/Kat/185 in this office for fixation and regulation of fee structure of the School. The Fee structure of the school has not been regulated till date and is being fixed and regulated for the first time. The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management and after considering the same, all relevant factors which govern the subject, and the trend in expenditure incurred by the school, the Committee finds it just and proper to fix and regulate the Tuition fee of the school as under:

The school management has fixed annual fee arbitrarily and exorbitantly in violation of the orders of the Committee operating in the field. The amount of fee charged for the facilities shared more or less equally by the students has been fixed differently for different classes. The instances may be drawn from the heads like school improvement fund, sweeping charges, building repair and maintenance, magazines etc. Also non relevant heads like security/Misc. has been added to annual fee component. Similarly the electricity fund which is actually a component of tuition fee is also added to Annual fee. There is also no justification for social activity fund charged under annual fee. These violations by the school management mandate the fixation and regulation of annual fee as per the set norms. The Committee therefore fixes and regulates the annual fee of the school as under:-
