During the examination of the record it transpired that the school management has abused and misused the order No.02 FFC of 2019 read with order No.01 FFC of 2019, to their Advantage and disadvantage of students/parents by making exorbitant increase of 19% to 31% in tuition fee of 2018-19.

On due consideration of the material produced by the School management and after considering the same, all relevant factors which govern the subject, the trend in expenditure incurred by the school, and the violations committed by the School management, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
