Sub: Fixation and Regulation of fee of Green Model Higher Secondary School, Doda.

Green Model Higher Secondary School, Doda vide application No. GMHSS/D/3511 date: 05.02.2021, has submitted file registered under No. FFRC/FF/2019/Doda/320 dated: 08.02.2021, through its Principal along with connected documents for fixation and regulation of its fee structure for the academic year 2020-21. The school has been established in the year 1977. The Committee for Fixation & Regulation of Fee of Private Schools, J&K (FFRC) came into the existence for the first time in the erstwhile state of Jammu and Kashmir in the year 2013. It however, became effectively functional in the year 2015.

The school management has for the first time approached FFRC through above referred application for fixation determination and regulation of its fee structure.
