Sub: Fixation and Regulation of fee of Sacred Heart Convent High School Phinter Billawar, Kathua.

Sacred Heart Convent High School Phinter Billawar, Kathua, Principal has filed an application which has been received by this office on 11.02.2021, registered under No. FFRC/FF/2018-21/Kat/98 dated: 11.02.2021, along with connected documents for fixation and regulation of its fee structure for the academic year 2020-21.

Perusal of the documents submitted by the School management show that the fee structure of School has not been regulated by the FFRC till date.

It may not be out of place to mention here that the School management has taken benefit of the order No. 01 FFC of 2019 dated 28.01.2019, notwithstanding, this fact that fee structure of the School was never regulated by the FFRC. The FFRC today for the first time got opportunity to consider the record of the School for determining, fixing and regulating its fee structure.

The record produced by the School management inter-alia amongst others shows following:

- a). The school has surplus amount of 20% as on 31.03.2020.
- b). In the financial year 2018-19 an amount of Rs.8738820/-has been transferred to the society.
- c). In the financial year 2019-20 an amount of Rs. 4949600/-has been transferred to the society.
- d). The Salary of some teaching staff has been reduced in the financial year 2019-20.
- e). In the components listed under annual charges, water & electricity charges have been included, besides this some irrelevant charges have been added.

The tuition fee is being paid to the School and has to be received by the School only and not any society. The tuition fee cannot be transferred to any other agency/society for catering to some different needs, other than enhancing the teaching capacity/salary of the staff.

The water & electricity charges being current charges constitute expense component and not expenditure component of the school. The amount of water & electricity charges have to be paid from tuition fee.

The school management, in view of mandate of the order of Hon'ble the Supreme Court may have surplus amount ranging between 10-15%.

In view of the aforesaid circumstances and on due consideration of the pleas raised by the School management and after consideration of record, all relevant factors which govern the subject, and the trend in expenditure incurred by the school, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
