**Oxford School of Education, Budgam** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bud/259.

The Committee vide Order No.FFC/FF/Ord-2018-19/3695 dated 18.12.2019 has fixed and regulated the tuition fee of the School for the **Session 2019-20** as under:

The Annual Fee of the School has not been regulated till date. The perusal of school record reveals that components which are not part of Annual Fee have been projected as elements of annual fee, and nursery classes, and some of lower primary classes have been saddled with fee which they are not required to pay. The previous orders 37 FFC of 2016 dated 26.04.2016, 101 FFC of 2017 dated 06.06.2017 and 390 FFC of 2018 dated 24.04.2018, have specifically restricted school management from charging any other fee, including annual fee, excepting the tuition fee which was regulated. The school management prima-facie appears to have charged and collected annual fee, notwithstanding the aforesaid orders. Principal and Chairperson of the school to show cause within one month why penal action in accordance with law is not taken against them.

On the overall assessment of the School records, it is deemed just and proper to fix the Annual Fee of the School for the academic session **2020-21** as under:



Charging and collecting of Admission Fee is prohibited by Statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non- compliance will attract penal action under law.
