The annual fee of the school has been fixed and regulated under No. FFC/FF/2018/Kat/95 dated 12.09.2019. As per the order the heads, miscellaneous fund, advertisement, social activity fund and school development fund where not considered and the school management was asked to provide justification for the same. The fresh record submitted by the school pertaining to the component of annual charges shows the heads, **“telephone, broadband and water charges”** which are actually component of tuition fee but have been added to annual fee. The component like festival, celebrations etc which is voluntary in nature is also added along with **“construction and earth work”**. After consideration of all other heads and related expenditures, the committee finds it just and proper to fix and regulate the annual fee as under; with the observation that in case of heads, **“construction and earth work”** and **“festival, celebrations”** the school management has to justify the charging of fee under these heads and continuation of the same as a component of annual fee, with proper documentary evidence, before the same is considered for fixation and regulation.


