The fee structure of the school has not been regulated till date and is being regulated for the first time. On examination of the records it transpired that the school management has fixed tuition fee of the school arbitrarily from Nursery to 12th class. The same needs to be regulated.

On due consideration of the material produced by the School management and after considering the same, all relevant factors which govern the subject, the trend in expenditure incurred by the school, , the Committee finds it just and proper to fix and regulate the fee structure of the school in terms of levels of schooling as under:-
