Order No: 39 -FFRC (FF) of 2021 Dated: 05 -04-2021

Sub: Fixation and Regulation of fee of St. Mary's Convent School Challan Ramkote, Kathua.

St. Mary's Convent School Challan Ramkote, Kathua submitted file for fixation and regulation of fee structure which is registered under No. FFRC/FF/2018-21/Kat/108. The perusals of the file reveal that the fee structure of the school has been regulated vide order No. 750 FFC of 2018 dated 03.12.2018. The said order also reveal that annual fee component of the fee structure was not regulated and record also shows that same has not been regulated till date. Annual fee is accordingly regulated for the first time.

The record also revealed that though the school has taken benefit of order No. 01 FFC of 2019 dated 28.01.2019 but has enhanced the fee not in accordance with the terms and conditions of the said order and has made an unjustified and unreasonable hike in the fee structure ranging between 10 to 12%.

The school management in view of the proviso 2nd of para-5 of order No. 01 FFC of 2019 dated 28.01.2019 was not authorized to make an abrupt and exorbitant enhancement in the fee structure. The enhancement in the fee structure had to be reasonable, gradual and commensurate with the expenditure of the school. Without any justification huge fee hike has been made.

Special celebration fee and activity fee has no nexus with the object sought to achieved, and are accordingly not considered under the component of Annual Fee at this stage.

On due consideration of the record provided by the School management and after considering all relevant factors which govern the subject, and the trend in expenditure incurred by the school, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
