Sub: Fixation and Regulation of fee of Little Angles Hr. Sec. School Ward No.1 College Road, Kathua.

Little Angles Hr. Sec. School Ward No.1 College Road, Kathua submitted file for fixation and regulation of fee structure which is registered under No. FFRC/FF/2019-21/Kat/93. The fee structure of the school has not been regulated by the Committee so far as the school management has not approached the Committee for the regulation of fee structure in compliance to orders issued from time to time in this regard.

The fee structure is being fixed and regulated for the first time. The fee structure fixed by the school management and the one proposed is not justified as the school has generated more than 20% surplus during last two years.

On one hand the tuition fee is received at exorbitant rates, on the other hand the school is paying salary to the staff below Rs.10000/- in majority of cases.

On due consideration of the record provided by the School management and after considering all relevant factors which govern the subject, and the trend in expenditure incurred by the school, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
