Sub: Fixation and Regulation of fee of Christ High School, Nowshera, Rajouri.

Christ High School, Nowshera, Rajouri submitted file for fixation and regulation of fee structure, registered under No. FFRC/FF/2018-21/Raj/206. The record and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On examination of material produced by the school it transpired that the school has made an abrupt and unreasonable hike in fee structure of 2018 in violation of Order No. 01 FFC of 2019.


