Sub: Fixation and Regulation of fee of Knit Green Model Academy, Gajay Singh Pura, Bhalwal, Jammu.

Knit Green Model Academy, Gajay Singh Pura, Bhalwal, Jammu submitted file for fixation and regulation of fee structure of the School for the first time on 18.02.2021, which has been registered in FFRC office under No. FFRC/FF/2019-21/Jmu/147. Perusal of the record show that the Secretary of the management of the committee of the Institution is owner of the property in which the School is housed. The record also shows that the School is paying rent @ Rs.1.00 Lac per month to the owner, who is Secretary of the management committee of the School as well. Prima facie it appears that the owner of the property is also owner of the School. The owner is receiving rent of Rs.12.00 Lacs annually from the School.

The setting up of an educational institution has been said by Hon'ble the Supreme Court to be charitable activity. An educational institution by whichever legal mode it comes into existence is a charitable and non-profitable noble activity. The record besides highlighting other things also shows that huge amounts have been spent on Travelling and Conveyance expenses. No details have been given about the Travelling and Conveyance expenses nor any receipt has been placed on the record. The amount of Rs.199,248.00/- has been shown to be spent for Travelling and Conveyance expenses. Similarly, an amount of Rs.456,354.00/- has been shown to have been spent on building repair and maintenance but neither details have been provided about the same nor any receipts have been placed on the record. Some other items have also been shown in which huge amounts have been shown to be spent but without any details and without any receipts being placed on record.

The fee structure of the School is to be regulated and fixed for the first time.



The record also shows that tuition fee as also annual fee which was being charged by the School in August' 2014 has made a huge unreasonable jump in the year 2017-18, 2018-19 & 2019-20. The fee fixed and charged in the academic session 2019-20 is same as in the year 2020-21. The reason for not having enhanced the fee is that the COVID-19 pandemic had brought all the activities to halt and schools were also shut down during this period.

The Committee at the moment is allowing the benefit of rent to the owner and is not adding this amount to the School corpus but is excluding it from the same. If the rental amount would be added to the School corpus, the tuition fee and annual fee which is being regulated and fixed for the first time would be lesser than that is being regulated and fixed by this order. This issue will be considered again.

Even the Principal of the institution was requested on 01.04.2021 by an e-mail to remain available along with Miss Bimla Baloria, Shri Jia Lal Kotwal and other member of the committee on 05.04.2021. The members of the School management, however, did not respond this communication and did not appear today in FFRC.

On due consideration of the material produced by the School management and after considering all the relevant factors which govern the subject and the trend in expenditure incurred by the School, the Committee finds it just and proper to fix and regulate the fee structure of the School as under::
