**Sub: Fixation and Regulation of fee of Presentation Convent Sr. Secondary School Gandhi Nagar, Jammu.**

**Presentation Convent Sr. Secondary School Gandhi Nagar, Jammu** submitted file for fixation and regulation of their fee structure registered under No. **FFRC/FF/2021/Jmu /29** in this office. Earlier the Committee has fixed and regulated the fee structure of the school and fixed the same for session **2018-19** as under:

During the examination of record it transpired that the fee structure of UKG has not been approved by the Committee vide its earlier order. The school at that stage had not shown the said class in its fee structure. The record now shows that the school was charging Rs.1675/- p.m in 2018-19 but has made an exorbitant hike from Rs.1675/- to Rs.2500/- in 2019-20. Also annual fee of the UKG has been fixed at Rs.19000/- annually. Both heads in the fee structure are exorbitant and need regulation under set norms.

On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, the trend and areas of expenditure, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:-


