Order No: 40 -FFRC (FF) of 2021 Dated: 07 -04-2021

Sub: Fixation and Regulation of fee of Sprawling Buds ICSE School Laxmi Puram, Bantalab Jammu.

Sprawling Buds ICSE School Laxmi Puram Bantalab, Jammu submitted file, registered under No. FFRC/FF/2019-21/Jmu /79 in this office for fixation and regulation of fee structure of the School. The fee structure of the school has not been fixed and regulated so far and the school management on its own has fixed an exorbitant fee structure which tantamounts to commercialization of education. The management by doing so has violated the orders of the Committee passed from time to time in this regard.

On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, the trend and areas of expenditure, surplus and comparative analysis of fee structures of Private Schools in Jammu with more or less similar infrastructure and facilities and keeping in view the violation by the school management, the Committee finds it just and proper to fix and regulate the fee structure of the school for the first time in terms of levels of the schooling as under:-

As per the record Sh.Rahul Sharma S/O sh.Jajinder Kumar Sharma is author of the Trust and Sh. Ramesh Kumar Khajuria S/O Sh. Ajudhya Nath Khajuria is a trustee in terms of trust deed.

The lease deed shows above trustee as owners of the property that has been leased out to the trust for establishment of school.

The School records also show that the owners/Trustees have received rent from the trust to the tune of Rs.2151380 in the year 2019-20 and must have received rent at enhanced rates for the next year.

The School record shows that, trust which has set up school is a public Trust.

A public Trust is created for the benefit of large section of society/people.

A public/Charitable trust is not set up for the benefit of a family and its members.

The School record shows that Trust funds/money paid by the students to school have prima facie been siphoned off in the name of rent from school/Trust and transferred to family members who are Trustees.

This act prima facie appears to be not in consonance with the aim of setting up a public /Charitable Trust.

This aspect would require to be thoroughly enquired into.

However, at this stage the FFRC is not adding the rent amount to the school/Trust corpus but is excluding the same at the moment while fixing fee structure of the school.



Had the rent amount been added to the school corpus, fee structure would have been further reduced.

The trustees are given three (03) months time to explain their position in this behalf.

After six months, this issue will be reconsidered and appropriate orders passed.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Non- compliance will attract penal action under Law.

(The school management shall display this approved fee structure on the school notice Board and upload the same on school website. The school management shall also publish the approved fee structure in a leading local news paper).
