Spring Dales School Rajouri Lines Akhnoor, Lower Barnai Jammu submitted file, registered under No. FFRC/FF/2019-2021/Jmu /74 in this office for fixation and regulation of fee structure of the School. The School has been established in the year 2016 and have 306 students on roll at present. The fee structure of the school has not been fixed and regulated so far and the school management on its own has fixed an exorbitant fee structure which tantamounts to commercialization of education. The management by doing so has violated the orders of the Committee passed from time to time in this regard.

The annual fee of the school has also not been regulated till date and is being fixed and regulated for the first time.

On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, the trend and areas of expenditure, and comparative analysis of fee structures of Private Schools with more or less similar infrastructure and facilities, and keeping in view the violation by the school management, the Committee finds it just and proper to fix and regulate the fee structure of the school for the first time as under:-
