Sub: Fixation and Regulation of fee of R. S. Jagriti Niketan Higher Secondary School, Kathua.

R. S. Jagriti Niketan Higher Secondary School, Kathua submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2019-2021/Kat/118.

The Committee vide No.FFC/FF/2019/Kathua/118 dated 09.09.2019 has approved and regularized the fee structure of the School for the **Session 2019-20** as under:

The record produced by the School reveals that it has in **violation** of FFC order issued vide No.FFC/FF/2019/Kathua/118 dated 09.09.2019, enhanced its fee structure during the **Session 2019-20** and charged the same during the **Session 2020-21** also, which is as under:

The aforesaid circumstances reveal that the School management in cruel disregard and brazen violation of FFC order No.FFC/FF/2019/Kathua/118 dated 09.09.2019 has fixed and charged the tuition fee and annual fee for the Session 2019-20 which is higher than the fee fixed by the Committee.

The Principal and Chairperson of the School to show cause as to why action in accordance with law be not taken against them.

The fee fixed by the Committee vide its order No.FFC/FF/2019/Kathua/118 dated 09.09.2019 holds good till date and School management is duty bound to reimburse the excess fee of the children or in the alternative adjust the same in future tuition fee and annual fee charges.

The Principal and Chairperson to file the reply within two (02) months time and on failure thereof appropriate orders in accordance with law will be passed.

Taking the fee fixed by the Committee vide its order No.FFC/FF/2019/Kathua/118 dated 09.09.2019, the fee structure of the School for the **Session 2019-20 & 2020-21 shall remain as under:**


