The Chairperson and principal to explain within one month as to why action in accordance with law may not be initiated and brought to logical conclusion against them.

The record of the school file reveals that chairperson of the trust is the owner of the property. The Trust has been registered U/S 12AA of the income Tax Act 1961. The terms and conditions of the aforesaid order prima facie, appears to have been observed in breach. Rent of Rs.12 lac.per anum has been fixed in the year 2013 and owner of the property is Chairperson of the Trust, thus is prima facie deriving benefit from a charitable Trust.

This issue will be considered after six months. In the meanwhile the school

management to submit explanation in this behalf within three months to FFRC.

In view of above circumstances, the rent amount at this stage is not added to school corpus, as by said process the fee fixed and regulated by this order would have been further reduced.

The school has generated a surplus of 14% to 16% during last three years .The continuous rising surplus tantamount to profiteering/Commercialization of education. Keeping this in view The Committee finds it just and proper not to allow further increase in annual fee at this stage.

On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, the trend and areas of expenditure, surplus and keeping in view the violation by the school management, facts enumerated hereinabove, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:-
