**Sub: Fixation and Regulation of fee of International Delhi public School Jammu.**

International Delhi Public School Sunjwan Jammu has been established in 2018-19.

The School management applied for the Regularization of the fee structure as was applicable in the school during 2018-19

The case was forwarded to the then C.A (member) after obtaining necessary information and the C.A (member) observed as under:-

*“As per report furnished by the school management and fee structure furnished by the management, it appears the fee structure is on higher side as in addition to the Tuition fee the school management is receiving admission fee and annual charges in every class. The fee structure seems on higher side. Keeping in view the fact the school is newly established, the fee structure need to be regulated reasonably”.*

On the instructions of the Hon'ble Chairman a team of FFRC visited the school on 02-02-2019 to verify the authenticity of infrastructure and facilities provided to the students and staff as claimed by the school .The team obtained some relevant documents in this regard.

The team briefed the then Hon'ble chairman regarding the infrastructure and facilities provided by the school and placed the documents collected from school management before Hon'ble chairman.

The then Hon'ble Chairman instructed that the case be placed before the Committee for consideration.

The case was accordingly placed before the Committee, the Committee observed that the fee structure is exorbitant and school management needs to justify the same. The Director School Education Jammu was asked to send a team of experts to the School for inspection and submit report before the case is Considered.

The inspection report was received from directorate of School Education Jammu vide No.DSEJ/PVT/32618 dated 18-10-2020.The report inter-alia states as under:-

*“The Committee is of the considered opinion that though the institution has good facilities, yet the fee structure, especially, the annual charges appears to be exorbitant. in the socio-economic society; as that of Jammu city and*



*surroundings an annual charge ranging between Rs.35000- Rs.40000 and monthly Tuition fee ranging between Rs.3000-Rs.4000 are definitely irrational and exorbitant”.*

Due to the expiry of the term of Hon’ble the Chairman, the file could not be considered.

After Constitution of the Committee, it vide order No.35 FFRC of 2021 dated 19-01-2021 asked the private schools to submit information as per the latest proforma.

**International Delhi public School Jammu in response to said order submitted the file in this office registered under No. FFRC/FF/2021/Jmu/10** for fixation and regulation of fee structure of the School. The fee structure of the school has not been regulated till date and is being regulated for the first time.

The annual fee of the school has not been regulated till date and is being regulated for the first time. The school has fixed annual fee exorbitantly in comparison to most of the leading schools in Jammu with more or less similar infrastructure, facilities and academic standard. The fact also observed by the expert Committee in its report.

On due consideration of the fresh material produced by the School management and after considering the relevant factors which govern the subject, the areas and trend in expenditure incurred by the school, and the report of the expert committee, the Committee finds it just and proper to fix and regulate the fee structure of the school as under:
