**Sub: Fixation and Regulation of fee of St. Mary's Convent High School
Smailpur Bari Brahmana, Samba.**

St. Mary's Convent High School Smailpur Bari Brahmana, Samba submitted file for fixation and regulation of their fee structure registered under No. FFRC/FF/2021/Samba/09 in this office. The fee structure of the school has not regulated by this Committee till date. The fee structure of the school is being regulated for the first time.

The school management has added Rs.200/- to the Annual Fee on account of electric and water charges. These electric and water charges are component of tuition fee. The amount of Rs.200/- are deducted from annual charges and added up as component of tuition fee.

8% hike is allowed in terms of order No. 106 FFC of 2017 dated 20.10.2017 and 6% in terms of order No. 01 FFC of 2019 dated 28.01.2019. The school fee is regulated and fixed on class level basis. On due consideration of the material produced by the school management and after considering all relevant factors which govern the subject, the trend and areas of expenditure, the Committee finds it just and proper to fix and regulate the fee structure of the school as under: -

Non-compliance will attract penal action under law.


