Indian Public School Kalibari Kathua submitted file, registered under No.FFRC/FF/2021/Kat/31 in this office for fixation and regulation of fee structure of the School. The fee structure of the school has not been fixed and regulated so far and the school management on its own has fixed an exorbitant fee structure which tantamounts to commercialization of education. The management by doing so has violated the orders of the Committee passed from time to time in this regard.

On due consideration of the material produced by the School management and after considering the same, all relevant factors which govern the subject, the trend and areas of expenditure, surplus and comparative analysis of fee structures of Private Schools with more or less similar infrastructure and facilities and keeping in view the violation by the school management, the Committee finds it just and proper to fix and regulate the fee structure of the school for the first time in terms of levels of the schooling as under:-
