St. Antony's Convent School, Gagore, Vijaypur, Samba submitted its file registered under No. Edu/FFRC/FF/2018-2021/Samba/104 in this office for fixation and regulation of fee structure of the School. Earlier the tuition fee of the school has been fixed and regulated by the Committee Vide Order No. 565-FFC of 2018 dated 09.10.2018 for session 2018-19. The record committee Vide Order No. 565-FFC of 2018 dated 09.10.2018 for session 2018-19 but has made an exorbitant hike now shows that the school was charging Rs.555/- p.m in 2018-19 but has made an exorbitant hike from Rs.555/- to Rs.630/- in 2020-21.


Annual fee has not been regulated and is being regulated for the first time. Annual fee was being charged at Rs. 3790/- from class I to VII and Rs. 4240/- from class VIII to X in 2018-19. The record now shows that the school has made an exorbitant hike in Annual fee from Rs. 3790/- to Rs. 5110/- from class I to VII and Rs. 4240/- to Rs.5770/- from class VIII to X in 2020-21 without any justification. The increase made by the school in Annual fee tantamounts to commercialization of Education. While considering material placed on record, it transpired that electricity charges have been made as component of Annual fee, when it has to be component of tuition fee, being a current expense. Also the head "celebration" being voluntary in nature is deleted accordingly.

The School has projected a deficit of Rs. 2159372.63/- in 2020. The analysis of financial statements shows that the school was in surplus during year 2018-19. In year 2019-20, the expenses of school are less than 2018-19 and also school has received Rs. 49,71,170/- from society and transferred Rs. 24,93,650/- to Diocese of Jammu-Srinagar Education Society.

On due consideration of the material produced by the School management and after considering, all relevant factors which govern the subject, the Committee finds it just and proper to fix and regulate the fee structure of the school as per levels of schooling as under:-
