Sub: Fixation and Regulation of fee of St. Joseph's Convent High School Dhoke Waziran Nagrota, Jammu

St. Joseph's Convent High School Dhoke Waziran Nagrota, Jammu submitted file for fixation and regulation of their fee structure registered under No.FFRC/FF/2018-21/Jmu/108 in this office. Earlier the Committee has fixed and regulated the tuition fee of the school vide order No.556 FFC of 2018 dated 09.02.2018.

The annual fee of the School was not regulated by this Committee till date and is being regulated for the first time.

On due consideration of the material produced by the school management and after considering all relevant factors which govern the subject, the trend in expenditure incurred by the school, and the reasonable enhancement the school has made in its tuition fee till date, the Committee finds it just and proper to fix and regulate the fee structure of the school on class level basis as under:

Non- compliance will attract penal action under law.


