Sub: Fixation and Regulation of fee of St. Paul's Convent High School Gangyal, Jammu.

St. Paul's Convent High School Gangyal, Jammu submitted file for fixation and regulation of their fee structure registered under No.FFRC/FF/2018-21/Jmu/99 in this office. In terms of order No. 359 FFC of 2018 date 07.03.2018, the Committee has allowed school management to enhance its tuition fee by 8% and in pursuance to order No.106 FFC of 2017 dated 20.10.2017, this hike was permitted in tuition fee of Rs.500/- as was existing in August'2014 in respect of class 1st – 10th.

On this principle the school fee for class 1st – 10th in academic session 2018-19 would be Rs.540/-.

Enhancing tuition fee by 6% as was provided in terms of order No.01 FFC of 2019 dated 28.01.2019, the tuition fee for class 1st – 10th would be Rs.575in the academic session 2019-20.

Due to onset of Covid-19 pandemic there was no hike in the fee structure for the academic session 2020-21.

In terms of order No.45 FFRC of 2021 dated 18.02.2021 no fee hike was permitted for the academic session 2021-22.

In view of the aforesaid circumstances the tuition fee for the academic session 2021-22 would be Rs.575/-.

The school record however, shows that it has of his its own, without any authority and justification fixed of Rs.720/- as tuition fee.

The school record also shows a surplus of 10.2% on 31.03.2020.

The annual fee of the School was not regulated by this Committee till date and is being regulated for the first time.

There has been unreasonable and unjustified fixation and increase in annual fee. The annual charges have been increased from 3550 to 6410. The tuition fee as also annual fee has to be regulated and fixed.

On due consideration of the material produced by the school management and after considering all relevant factors which govern the subject, the trend and areas of expenditure,
