**Radiant Model Public School (RMP) Lower Khonmoh, Srinagar** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2020/Sgr/212**.

The Committee vide Order No.688-FFC of 2018 dated 19.11.2018 has approved the tuition fee of the School for the **Session 2018-19** as under:
