**Sub: Fixation and Regulation of fee of Satisar Educational Institute, Tulbagh, Pampore, Pulwama.**

Satisar Educational Institute, Tulbagh, Pampore, Pulwama submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Pul/227.

The fee structure of the School has to be fixed and regulated by the Committee for the first time.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, and the trend in expenditure incurred by the School, the Committee finds it just and proper to fix and regulate the fee structure of the School as under:

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non- compliance will attract penal action under law.


