Al-Hira Educational Institute, Gangipora, BK Pora Budgam submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bud/253**.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management and after considering all relevant factors which govern the subject, and the trend in expenditure incurred by the School, the Committee finds it just and proper to fix and regulate the fee structure of the School as under:




