The school record reveals that by way of a general order issued vide No 02 FFC of 2019, dated 4 Feb 2019, the school in question was also given liberty to proceed in terms of order No 1 FFC of 2019, dated 28 Jan 2019 with rider, that while regulating/enhancing the fee structure the school should adhere to the terms and conditions contained in the said order.

Order No 45 FFRC of 2021 dated: 18.02.2021 restrained schools from making any hike in fee in academic session 2020-21.

The above detailed-out fee structure would show that the school management has brazenly abused and misused order No 01 of 2019 in as much as it has enhanced the fee structure from one academic session to another academic year by a margin ranging between 13% to 33%. Hon'ble the Supreme Court has provided that the schools should have surplus of 10-15% which is to be spent for enhancing the skills of the students. The fixing of fee by school management itself has resulted not only in profiteering but undue profiteering and commercialization of education.

In order to regulate the Fee Structure of the school in accordance with the settled norms, it is ordered as under:

- (a) That the present fee structure of the school shall remain static and same for the academic session 2021-22 and 2022-23.
- (b) The school management is restrained from making any enhancement in any type of fee structure for the aforesaid academic sessions.
- (c) The school management is at liberty to seek any enhancement in fee structure by approaching the FFRC strictly in accordance with mandate



- contained in JK School Education Act 2002 as amended till date and rules made there under.
- (d) The school management shall display the fee structure for three academic sessions i.e. 2020-21, 2021-22 and 2022-23 on the school website and notice board.
- (e) The students and the parents shall be informed about this order.
