Classic Public High School, Goom, Ahmadpora, Magam, Singhpora, Pattan, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/300**.

The fee structure of the School has to be fixed and regulated by the Committee for the first time.

The School has maintained the fee structure for the academic session 2020-21 as was during the academic session 2019-20, which the School was otherwise bound to do in terms of **the Order No.45-FFRC of 2021 dated 18.02.2021**. The School has also started Pre-Nursery class in the academic session 2020-21.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to fix and regulate the fee structure of the School as under:
