**Sub: Fixation and Regulation of Fee of Al Asma Educational Institute, Budgam.**

Al Asma Educational Institute, Budgam submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bud/283. The Committee vide Order No. FFC/FF/2018/Bud/84 dated 09.07.2019 has approved the tuition fee of the School for the Session 2018-19.

The annual fee of the school has not been regulated till date and is being regulated for the first time.

The Annual Fee statement of the School shows that not only irrelevant heads/overheads have been added, but the annual fee for lower classes for the heads/overheads is being charged which is not relevant to the said classes.

After taking into consideration the material available on record and the norms governing the field the annual fee of the school is regulated for academic session 2020-21 as under:

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

**Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.**

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
