**Sub: Fixation and Regulation of fee of Valley Commonwealth High School,  
Rampora Weir, Chattabal, Srinagar.**

Valley Commonwealth High School, Rampora Weir, Chattabal, Srinagar submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Sgr/241**.

The fee structure of the School has to be fixed and regulated by the Committee for the first time.

Children at the level of 1<sup>st</sup> to 5<sup>th</sup> may not be using the Computer Lab. in the manner it is being used by the children studying in higher classes. Charging and collecting computer fee @ Rs.500/- is not justified and tantamount to commercialization of education. After considering the same and the norms governing the field, it is deemed just and proper to regulate the **Annual Fee** of the School for the academic session **2020-21** as under:

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee/ Admission Fund is prohibited by statutes. **The school management is prohibited from charging and collecting admission fee/admission fund from the students.**

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and expenditure of the school on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
