Sub: Fixation and Regulation of Fee of Khushall Valley Educational Trust Upper Ahmadnagar Pandach, Ganderbal.

Khushall Valley Educational Trust Upper Ahmadnagar Pandach, Ganderbal submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Gbl/345.

Vide order No. 168 FFC of 2019 dated 27.10.2017 School management has been given benefit of enhancement of fee in terms of general order No. 106 FFC of 2017 date 20.10.2017. The fee structure of the school, however, is being regulated for the first time by this order.

Perusal of the record shows that the school management has provided some documents which prima facie contradict each other.

In proforma-B the school management has provided detailed information about annual fee charged at present. One of the sub-heads in the proforma-B at serial No.02 is "picnic" for which Rs.300/- are being charged and collected.

Picnic fee is a voluntary fee and is not component of annual fee.

Unless student avails of the benefit of the picnic/tour they cannot be charged with the picnic fee.

Furthermore there cannot be a fixed picnic fee, in as much as the fee to be charged and collected one this count would depend on the area/location where the students are taken for picnic purpose.

As stated herein above the details about annual fee vary from the fee structure which has been published in newspaper.

The school management shall be careful in future in providing the information to FFRC and should make clean breast of all the facts truthfully.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:

The school management is at liberty to collect annual fee in any number of installments, the payment whereof will be convenient to parents/students.

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization of education completely.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
