Fixation and Regulation of Fee of Salsabeel Educational Institute Humhama, Budgam submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bud/302. The Fee structure of the school has been regulated vide order No. 342 FFC of 2018 dated 21.02.2018.

The annual fee of the school has not been regulated till date and is being regulated for the first time.

After taking into consideration the material available on record and the norms governing the field the annual fee of the school is regulated for academic session 2020-21 as under:

The school record shows that for classes Pre-Nursery to Ist the school management is charging Rs.850/- as monthly tuition fee for classes 2nd to 3rd Rs.800/- is being charged.

After giving thoughtful consideration to the entire conspectus of case and balancing the interest of all stake holders and considering the norms governing the field, it is ordered that the fee tuition fee for classes Pre-Nursery to Ist will remain static and will not be carried forward along with promotion of child to 2nd class.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to fix and regulate the fee structure of the School as under:

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
