**Sub: Fixation and Regulation of fee of Gazi Memorial Institute, Soaf Shali, Kokernag, Anantnag.**

**Gazi Memorial Institute, Soaf Shali, Kokernag, Anantnag** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Ang/248**.

Vide Order No.91-FFRC (FF) of 2021 dated 28.04.2021, FFRC regulated the fee structure of **Gazi Memorial Institute, Soaf Shali, Kokernag, Anantnag**.

On 4th of May' 2021, the Principal of the said institute sent a mail wherein he informed the FFRC that fee has been regulated on the basis of the fee of the academic session 2018-19, which in turn has resulted in decrease of existing fee of the school. The record of the school was again considered. The record of the school showed that the school management had provided fee structure as it existed on Aug' 2014, Apr' 2017, Apr' 2018 as also the present fee. The school management had not provided the fee of the previous three (03) academic sessions. The fee of Aug' 2019 was accordingly taken to be the fee for the academic session 2019-20 and in view of order No.45-FFRC of 2021 dated 18.02.2021, same was taken to be fee for the academic session 2020-21 as well.

However, in view of the mail dated 4<sup>th</sup> of May' 2021 of the school, the school management was asked to submit detailed fee structure for the session(s) 2018-19, 2019-20 & 2020-2021. The Principal of the school in the mail dated 7<sup>th</sup> of May' 2021 has submitted the fee details of the aforesaid academic sessions.



7<sup>th</sup> of May' 2021, on account of Jummat-ul-Vida, was public holiday, 8<sup>th</sup> of May' 2021 no work day, 9<sup>th</sup> of May' 2021 Sunday and 10<sup>th</sup> of May' 2021 was public holiday on account of Shab-i-Qadar.

The mail dated 7<sup>th</sup> of May' 2021 of the school management was accordingly downloaded and printed today on 11<sup>th</sup> of May' 2021.

The fresh documents submitted by the Principal of the school show that the fee which has been taken to be fee for the academic session 2019-20 is infact fee of the academic session 2018-19. The tuition fee of the school submitted by Principal on 7<sup>th</sup> of May' 2021 for the academic session(s) Nov' 2018 - Oct' 2019, Nov' 2019 - Oct' 2020 & Nov' 2020 - Oct' 2021 is taken note of:

The fee structure for the aforesaid three (03) academic sessions sent as an attachment of mail dated 07.05.2021, reveal that school management in view of insufficient material submitted by it earlier, has been subjected to avoidable hardship. It becomes duty of the FFRC to mitigate the hardship to which the school management has been subjected to and is duty bound to meet out justice to school management.



In view of aforementioned circumstances and in order meet out justice to the school management, Order No.91-FFRC (FF) of 2021 dated 28.04.2021 is hereby recalled.

Considering the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the school, the fee structure of the school is regulated as under:

The Annual Fee of the school has not been regulated till date. The school record shows that it has charged and collected an amount of Rs.35,600/- as Admission Fee and Rs.15,900/- as Admission Fund, in the financial year 2019-20, from the students at the time of admission in the school. Charging and collecting of Admission Fee is prohibited by statutes. **The school management is prohibited from charging and collecting admission fee and admission fund from the students.**

In view of aforesaid circumstances, it becomes imperative to suitably and reasonably enhance the annual fee to enable school management to carry on its affairs, in the interest of students, in hassle free manner. After considering the entire conspectus and the material available on the record, the annual fee for the academic **Session 2020-21** is fixed and regulated as under:

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization of education completely.

Charging and collecting of Admission Fee is prohibited by statutes. The School Management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

The School management shall display this approved fee structure on School notice board and upload it on School website.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and expenditure of the school on relevant overheads.

Non- compliance will attract penal action under law.


