Badasgam, Hakura, Dooru, Anantnag.**

**Badasgam Public Model School, Badasgam, Hakura, Dooru, Anantnag**  
submitted file for fixation and regulation of fee structure of the School, which has  
been registered in FFRC office under No. **FFRC/FF/2021/Ang/305**.

The fee structure of the School has to be fixed and regulated by the Committee  
for the first time.

The Annual Fee of the School has not been regulated till date. The school  
record shows that electricity fund has been made component of the annual fee,  
whereas electricity charges are element of tuition fee. Furthermore, the income and  
expenditure account for ending on 31<sup>st</sup> March'2020 shows that no amount on account  
of electricity charges has been spent/paid. Besides this, at lower class level, computer  
fee cannot be charged and if this facility is provided to students then it cannot be  
charged at higher rate. After considering the same and the norms governing the field,  
it is deemed just and proper to fix and regulate the **Annual Fee** of the School for the  
academic session **2020-21** as under:



The record also shows that the school has been charging Admission Fee and Admission Fund. Charging and collecting of Admission Fee/ Admission Fund is prohibited by statutes. **The school management is prohibited from charging and collecting admission fee/admission fund from the students.**

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:


