**Sub: Fixation and Regulation of Fee of Greenland English Medium School
Doulatpora Athoora, Baramulla.**

Greenland English Medium School Doulatpora Athoora, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/281**. The Committee vide Order No. 759 FFC of 2018 dated 07.12.2018 has regulated the tuition fee of the School for the Session 2018-19.

The annual fee of the school has not been regulated till date and is being regulated for the first time.

The record about annual fee shows that school management is charging fee under sub-head "Science Fee" from Nursery to 5th class. The record also shows that school management does not charge computer fee for KG classes and is charging computer fee for other classes. The science fee for Nursery to 5th class is being charged without necessity of providing such facility to students of said classes. The annual fee under sub-head "Science Fee" is ordered to be not charged and collected from students of Nursery to 5th class.

After taking into consideration the material available on record and the norms governing the field the annual fee of the school is regulated for academic session **2020-21** as under:

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting admission fee from the students.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
