Sub: Fixation and Regulation of fee of Madina Public High School, Gund Khawaja Qasim, Pattan, Baramulla.

Madina Public High School, Gund Khawaja Qasim, Pattan, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bla/293**.

This School also figures in the list appended to order No.02-FFC of 2019 dated 04.02.2019.

The perusal of the school records shows that there is huge yawning gap in the Annual Fee of already enrolled students and the new enrolled students. For instance, in the school the Annual Fee for already enrolled students for Nursery to UKG is Rs.400/- whereas for new enrolled students it is Rs.2500/-. No justification is forthcoming from the record for such huge difference in the Annual Fee of the already enrolled students and new enrolled students.

The record further shows that irrelevant heads have been added to the Annual Fee and those items which are current expenses are also added to Annual Fee which exclusively relates to the expenses of the school. The Annual Fee is charged for creating long term benefits for the schools.

There is no justification in making huge and unreasonable hike in Annual Fee for new enrolled students. This unjustified hike leads to commercialization and

profiteering of education. In order to regulate the fee structure which includes Annual Fee of the school and on the basis of the settled norms thereof, the **Annual Fee** of the school is regulated as under:

On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **Tuition Fee** of the School as under:

Charging and collecting of Admission Fee is prohibited by statutes. **The school management is prohibited from charging and collecting admission fee from the students.**

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
