**Sub: Fixation and Regulation of fee of Mother Khadija Mission School, Housing Colony, Ompora, Budgam.**

Mother Khadija Mission School, Housing Colony, Ompora, Budgam submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Bud/280**.

The fee structure of the School has to be fixed and regulated by the Committee for the first time.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non- compliance will attract penal action under law.
