Sub: Fixation and Regulation of fee of Naunihal Public Secondary School, Behrampora, Baramulla.

Naunihal Public Secondary School, Behrampora, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/261.

The fee structure of the School has to be fixed and regulated by the Committee for the first time.

The audit report in respect of receipts and payments account ending 31st March' 2020 shows expenses of Rs.672/- on account of newspapers and periodicals. The detailed statement in respect of annual dues provided by the school shows that the newspaper fund is being charged and collected from the students of 1st to 10th class @ Rs.150/- and for the students of Nursery to UKG @ Rs.100/-. The total roll of the students at present is 396. Similarly, an amount of Rs.150/- is being charged and collected for providing laboratory and library facilities to the students of Nursery to UKG and Rs.200/- from the students of 1st to 5th class. The library and laboratory facilities are not required for the students of Nursery to 5th class. The newspaper fund cannot be charged and collected from the students of Nursery to 5th class as newspapers does not have any bearing on their academic pursuit. Even otherwise, as already stated an amount of Rs.672/- has been spent for the academic session for newspaper and periodicals. The students of Nursery to 5th class are not liable to pay

newspaper fund. After considering the same and the norms governing the field, it is deemed just and proper to regulate the **Annual Fee** of the School for the academic session **2020-21** as under:

Charging and collecting of Admission Fee/ Admission Fund is prohibited by statutes. The school management is prohibited from charging and collecting admission fee/admission fund from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
