Sunrise Quality Public School, Kitchama, Fatehgarh, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No.FFRC/FF/2021/Bla/279.

The School Management in terms of Order No.01 of 2019 dated 28.01.2019 has itself fixed the Annual Fee from 2018-19, but has not collected the same in view of lock-down and Government orders.

After considering the peculiar circumstances as stated above and on the overall assessment of the School records and the norms governing the field, it is deemed just and proper to regulate the **Annual Fee** of the School for the academic session **2020-21** as under:

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non- compliance will attract penal action under law.
