Sub: Fixation and Regulation of fee of Islamiya Model Middle School, Kangroosa, Dangiwacha, Rafiabad, Baramulla.

Islamiya Model Middle School, Kangroosa, Dangiwacha, Rafiabad, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/242.

The fee structure of the School has not been regulated in accordance with law and settled norms till date. The School Management has availed the benefit of Order No.106 - FFC of 2017 dated 20.10.2017, which is general in nature. The fee structure of the School is to be regulated in accordance with law and norms for the first time by this order.

The School Management has stated that it has to set-up Computer Lab. and Science Lab. Perusal of the school record shows that the School Management is charging Science Fund and Computer Fee from the students of LKG, UKG and Class 1<sup>st</sup>, whereas said facilities are inconsequential for the students of these classes.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the fee structure of the School as under:
