New Vishwa Jyoti Shishu Niketan High School Khoon, Udhampur submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Udh/09**


The Fee structure of the school has to be regulated by the Committee for the first time.

School management has submitted proposal for fixing and regulating annual charges.

The record of the school was considered. On consideration of material provided, norms governing the subject and considering the issue from the perspective of overall development of students, and to enable the school management to provide all necessary facilities, and for future development of school, the annual fee for academic session 2021-22 is fixed and regulated as under:

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the school on relevant overheads.
