Sheikh Ul Alam Secondary School Dhobiwan Tangmarg, Baramullla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/306. The Fee structure of the school has been regulated by the Committee vide order No.393 FFC of 2018 dated 24.04.2018 for academic session 2017-18.

The Principal of school has sent the explanation and copy of trust deed. The Principal has stated that for providing better educational facilities commensurate to future demands the fee structure needs to be suitably regulated.

The record shows that school management is adding charges of computer fee and smart class fee to tuition fee. These charges cannot be part of tuition fee, but will from component of annual fee, in as much as, they are not current expenses, but expenditure spread over to many academic sessions. These charges are accordingly made part of annual fee.

The school management will be at liberty, subject to convenience of parents, to charge and collect annual fee in installments.

The annual fee of the school has not been regulated till date and is being regulated for the first time.

Non-compliance will attract penal action under law.
