Sub: Fixation and Regulation of fee of Paramount Higher Secondary School, Tondwah, Doda.

Paramount Higher Secondary School, Tondwah, Doda submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Doda/116.

The **fee structure** of the School has to be regulated by the Committee for the first time.

The School has maintained same tuition fee for academic session 2018-19, 2019-20 & 2020-21.

Electricity and Phone Charges are current expenses and constitute a component of Tuition Fee and are accordingly deleted from Annual Fee.

Library Improvement Fund and Laboratory Improvement Fund for higher classes are on higher side. But in view of deletion of Electricity and Phone Charges from Annual Fee, no deduction is made in Library Improvement Fund and Laboratory Improvement Fund at this stage.

The School record also shows that huge amount has been spent on refreshments. Besides this, Picnic and Educational Tours are voluntary measures and charging fee, by making it component of any kind of fee is not permissible in law. Such type of charge can be made when Picnic/Educational Tour is undertaken.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the

School as under:

Charging and collecting of Admission Fee is prohibited by statutes. The school management is prohibited from charging and collecting Admission Fee from the students.

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

Realization of Annual Fee from the students shall be subject to providing the facilities to students and expenditure of the school on relevant overheads.

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
