The School Management shall not charge and collect any amount on account of Electricity and Telephone as component of Annual Fee. These are current expenses and component of Tuition Fee. These charges, accordingly, are not allowed as components of Annual Fee.

The record produced and the justification given by the School management for fixation and regulation of fee structure of the School was examined. On due consideration of the material produced by the School management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:
