Pioneer Institute of Learning, National Highway, Hanjiwera, Pattan, Baramulla submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. FFRC/FF/2021/Bla/331.

This School also figures in the list appended to order No.04-FFC of 2019 dated 25.02.2019 in terms of order No.01-FFC of 2019 dated 28.01.2019.

The Chairman of the School has submitted explanation as sought for. He has now stated the documents already submitted alongwith file about Annual Fee is infact proposal for enhancement of Annual Fee.

It is also stated that Annual Fee has not been collected during the academic session 2019-20 and has not been collected as on date for the session 2020-21.

The Chairman has also stated that fee has been hiked by School Management in pursuance to order No.01-FFC of 2019 dated 28.01.2019.

The record shows that the fee structure of the School has never been regulated, and by a general order, the School has been permitted to make hike in fee. In law and in fact till passing of this order, fee structure of School has not regulated.

The fee structure of the School is being regulated for the first time by this order to ensure that School Management does not indulge in commercialization and profiteering of education.

The record produced by the School Management was considered. The claim of the School Management was considered in accordance with norms set out in various judgements and fixed by statute. On overall consideration of material and all aspects governing the field, the Annual Fee of the School for academic session 2020-21 is regulated as under:

Non-compliance will attract penal action under law.
