Sub: Fixation and Regulation of fee of Play Way House Higher Secondary School, Pouni Chack, Ghomanasa Road, Jammu.

Play Way House Higher Secondary School, Pouni Chack, Ghomanasa Road, Jammu submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2021/Jmu/45**.

The **fee structure** of the School is being regulated by the Committee for the first time by this order.

Record shows that in the guise of Annual Fee, School is charging and collecting Admission Fee. Charging and collecting of Admission Fee is illegal and is barred by statutes.

The School record shows that **Annual Fee** is being separately charged by School Management. The School Management has been charging **Rs.5000/- as Admission Fee** in all classes and has surreptitiously styled it as **Annual Fee** while admitting child in the School.

The school management is prohibited from charging and collecting **Admission Fee** from the students.

The record also shows that School Management is charging **Electricity and Telephone Fee** as component of **Annual Fee**. **Electricity and Telephone Charges** are current expenses and constitute component of **Tuition Fee**. The **Electricity and Telephone elements** are accordingly deleted from **Annual Fee**.

The School record also shows that it has maintained same fee structure, in view of COVID-19 pandemic, for academic session 2019-20 and 2020-21.

In view of **Order No.45-FFRC of 2021 dated 18.02.2021**, the School Management has to maintain the same fee structure for the academic session 2021-22.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as under:



The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.

Non-compliance will attract penal action under law.
