**Sub: Fixation and Regulation of fee of Sri Guru Harkrishan Memorial High School, Simbal Camp, Miran Sahib, R. S. Pura, Jammu.**


**Sri Guru Harkrishan Memorial High School, Simbal Camp, Miran Sahib, R. S. Pura, Jammu** submitted file for fixation and regulation of fee structure of the School, which has been registered in FFRC office under No. **FFRC/FF/2017-21/Jmu/35**.

The Committee, vide Order No.150-FFC of 2017 dated 23.10.2017 has fixed the tuition fee of the School for the **Session 2017-18**. The Annual Fee has not been regulated and the School Management was asked to provide justification for each head to enable the Committee to regulate the Annual Fee.

The School record shows that without getting the Annual Fee regulated, the School Management has not only been charging the Annual Fee but has made hike in same during the academic session 2018-19.

The Income/Expenditure and Receipts & Payments account for the financial year ending 31<sup>st</sup> March' 2020 show that the School Management has charged for academic session 2019-20 an amount of Rs.25,000/- from students as Picnic Charges and has spent an amount of Rs.49,483/- on Advertisement and Flex. Besides this, Electricity Charges and Rent seems to be taken as component of Annual Fee.

Excursion/Picnic is a voluntary fee and is not and cannot be charged and collected as component of either Tuition Fee or Annual Fee.



The School is not a commercial unit and spending of huge and unreasonable amount on advertisement and flex is uncalled for. The Electricity Charges and Rent being current expenses will not constitute components of Annual Fee, but will be elements of Tuition Fee.

The record further shows that the School Management has maintained the same fee structure from academic session 2019-20 till date and has not collected Annual Fee for the academic session 2020-21. The same fee structure is to be maintained for academic session 2021-22 in terms of **Order No.45-FFRC of 2021 dated 18.02.2021**.

The Committee has given thoughtful consideration to the fact that besides not collecting Annual Fee for the academic session 2020-21, the School Management has maintained the same fee structure for three consecutive academic sessions. Accordingly, while regulating fee structure, this aspect has also been kept in mind.

The **Annual Fee** of the School is being regulated by the Committee for the first time by this order.

The record produced and the justification given by the School Management for fixation and regulation of fee structure of the School was examined. The same was considered in accordance with norms set out in various judgements and fixed by statute. On due consideration of the entire conspectus of the school record and acknowledged parameters and settled norms for regulating the fee structure of the School, material produced by the School Management, income and expenditure of the School and after considering all other relevant factors which govern the subject, the Committee finds it just and proper to regulate the **fee structure** of the School as

The aforesaid exercise has been undertaken and fee structure regulated in a manner that excluded the commercialization and profiteering of education completely.

**Charging and collecting of Admission Fee/ Admission Fund is prohibited by statutes. The school management is prohibited from charging and collecting admission fee/admission fund from the students.**

The School management is directed not to charge any other fee from the students other than the fee approved by the Committee.

The School management is further directed not to make any future enhancement in fee structure under any head without permission of the Committee.

**Realization of Annual Fee from the students shall be subject to providing the facilities to students and actual expenditure of the School on relevant overheads.**

The School management shall display this approved fee structure on School notice board, upload it on School website and publish the same in local daily newspapers.


Non-compliance will attract penal action under law.
